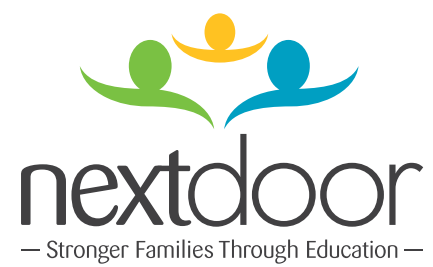

Our Center-Based Program

Every day, Next Door welcomes hundreds of children – from six weeks to age five – to our 29th Street and Capitol Drive campuses for impactful early childhood programming.

We provide children with their first classroom-based experiences and focus on building academic, social-emotional, and physical development. We add further engagement outside the classroom in our libraries, art studios, hallways, indoor and outdoor play spaces, and at family events. **Below is a look at our impact for the 2021-2022 school year.**

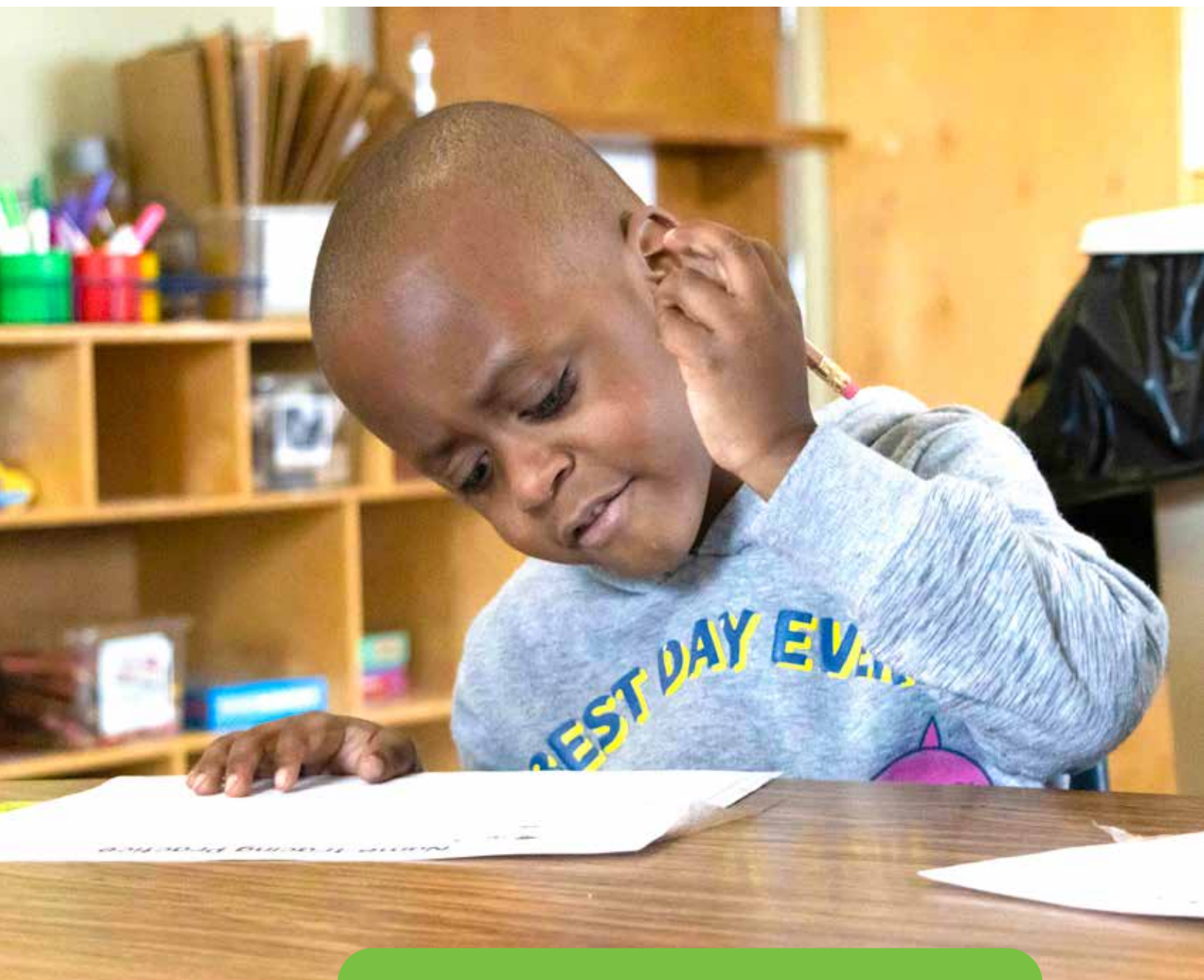

Devon is diligently working on his number tracing — practicing the number “1” at this time. The activity is part of a daily worksheet exercise in his K4 classroom. Building early writing development through tracing is one of the ways Next Door is preparing children for elementary school. Our teachers often intertwine disciplines — like writing and math — to expand learning opportunities for students and accelerate their growth.

Expanding Learning Opportunities

Robotics Education

Next Door students, Asher and Trenton, are learning how to program and operate the *Code & Go Robot Mouse*. **This is one of the new robotics tools that 194 students in K4 and K5 are using to develop an early understanding of concepts like coding, while problem solving and building important life skills.**

Teachers are also using books, Smartboard exercises, and sets of directional cards for children to program for various activities. They are aligning the robotics lessons with classroom curriculum so children can expand on what they are learning every day, with particular emphasis on literacy and math.



Art Education

In 2022, Next Door expanded art education with the hiring of a full-time Arts Education Coordinator. She works directly with children, like Rayina, pictured here. At the time, Rayina and her classmates were designing flowers with watercolors and crayons as part of a celebration of spring.

The coordinator plans programming for children ages two to five years old. She engages with them in our art studios and in classrooms. She also supports our Home-Based students by providing kits for at-home projects and offers additional touch points with art during family engagement events throughout the year.

Our Home-Based Program

Next Door's Home-Based Program offers year-round pregnancy support for expecting mothers and serves families of young children with early childhood education and student support services.

Our Parent Educators visit families once a week, offer services in multiple languages, coach parents on effective teaching tools, and help ensure families' basic needs are met. We also plan special events for our families at Next Door to provide additional services, story time in the library, and play date experiences.

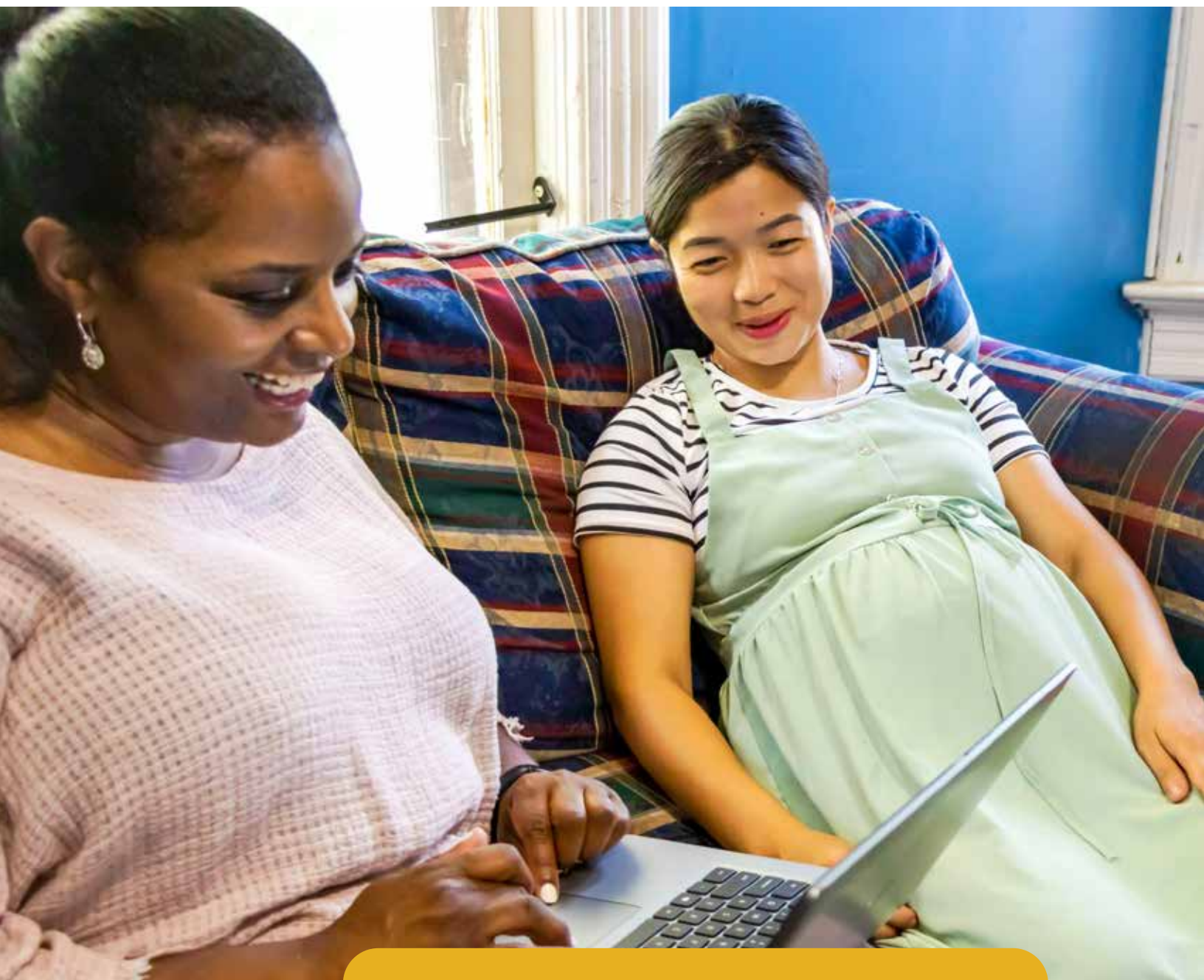

Next Door Parent Educator, Sana, meets weekly with Paw Kaw at her home in Milwaukee. Over the past year, Sana has guided her through her pregnancy with prenatal assessments, resources to keep mom and baby healthy, and techniques to support babies like infant massage. Paw Kaw and her husband have two other children – both former Next Door students. Our Parent Educators further support families by ensuring they have access to food, wellness exams, counseling services and holiday gifts.

Our Child Care Partnership Program

Since 2015, Next Door has been the leader of a Child Care Partnership (CCP) program with early childhood organizations across Milwaukee. This program strives to improve the quality of learning at our 13 partnership sites through year-round training and professional development for teachers from Next Door Instructional Coaches.

In addition, Next Door Family Advocates support families at the partnership sites with household goals and needs. We also offer healthcare resources and special education services. **A list of our partnership sites is included below, as well as statistics highlighting our impact during the 2021-2022 school year.**

Latrice and her daughter Si'Anna are a family from the Elaine Schreiber Child Development Center – one of Next Door's 13 early childhood partnership sites in Milwaukee. Here, they stopped by Next Door's Mobile Library to select free books to build their home library. Our Mobile Library visits each partner site quarterly to distribute books to young children and host family literacy activities.

Our New Workforce Development Strategy

To most effectively serve our children and families, we need to continually invest in our staff. In 2022, we enhanced our investment in workforce development through the creation of a new department dedicated entirely to this critical area. We are:

- **Recruiting and developing men and women interested in teaching in response to the growing teacher shortage**
- **Providing career advancement opportunities and year-round professional development programming for our current staff**
- **Supporting staff with resources to remove obstacles to successful employment at Next Door**



Pathways Program

- 6 unique Pathways to earn early childhood credentials, associate's degrees, and bachelor's degrees – at no cost to participants
- Open to public and Next Door employees
- 32 people completed one or more pathways since the program began in 2021

Success Coaches

- Providing one-on-one employee support for personal/professional goals
- Addressing areas like personal finances, home-buying, and resume/interview coaching to advance within Next Door
- 133 completed action plans during the 2021-2022 school year



Professional Development Team

- Organizing year-round professional development days/trainings for staff
- 180+ hours of programming provided to teachers in the 2021-2022 school year
- Supported additional agency-wide trainings in Trauma Sensitive Schools, Compassion Resilience, Financial Wellness and Stress Management



Community Partner Spotlights

Community partnerships are one of the ways we enhance our impact on the children we serve each year. Next Door currently partners with more than 30 local and national organizations who support the academic, social-emotional, and physical health needs of our young learners.



Brook Lopez and the NBPA

Brook Lopez with the Milwaukee Bucks partners with Next Door as part of his "Blocks for Books" program.

For every block he makes during the season, he contributes funding that helps Next Door purchase new books for children across our programming and build their home libraries. His gifts are matched by the National Basketball Players Association (NBPA) Foundation, which has resulted in more than 25,000 new books for Next Door students.



The Literacy Lab

Next Door partners with The Literacy Lab and its Leading Men Fellowship to provide young men of color the opportunity to serve as early childhood educators for a year.

The fellows receive training/coaching from The Literacy Lab and work alongside our teachers to support our children's education. These young men also provide needed male role models for our students. We currently have four graduates of the fellowship teaching at Next Door.



LENA

Our partnership with LENA, or Language Environmental Analysis, provides special recording devices to track the quantity and timing of conversational interactions between students and teachers during the school day. We place the devices in vests worn by our children. This work guides coaching to improve classroom language instruction at Next Door and our partnership sites.



Milwaukee Area Technical College

We partner with Milwaukee Area Technical College on our Pathways workforce development program to provide Next Door teachers, like Debra, a chance to advance their education and teaching position.

MATC supports several of our pathways through coursework that leads to an Infant Toddler Badge, an Early Childcare Educator Technical Diploma, and an Associate's Degree in early childhood education. MATC staff have also worked with Next Door to evolve Pathways programming to fit our students' schedules and needs.



Ignite Child Development Services

Next Door is the first Wisconsin organization to partner with Ignite Child Development Services. **Ignite provides on-site specialists daily to serve children with autism and behavioral challenges.** The specialists work with students one-on-one in and outside of the classroom. They have been especially important in light of a rise in student needs over the past year.



Familia Dental

We welcomed Familia Dental to Next Door in 2022 as a new partner for our Health Services department. **They provide our students with free dental screenings, cleanings, and fluoride treatments at on-site mobile clinics during the school year.** We also refer families to their offices for additional needs and a permanent dental provider. These services are available to children enrolled in our center-based sites and in our Home-Based program.

Federal Review

The outcome of the Federal Monitoring Review for 2021-2022 indicated that Next Door was in full compliance with the Head Start/Early Head Start program and performance standards, regulations and policy requirements.

Independent Federal Audit

Next Door continues to demonstrate strong financial and operational controls. The agency-wide audit for fiscal year ending June 30, 2022, continued a determination of low risk audit status.

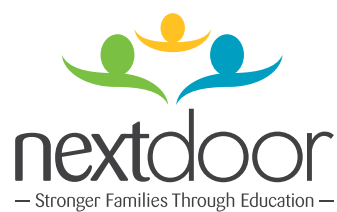
